WHEREAS, the Town Board (the "Board") of the Town of East Bloomfield (the "Town") having previously authorized the purchase of a 2017 Volvo Model #EW180E Wheeled Excavator (the "Equipment") for the Town's use and the financing thereof to partially defray the costs of the Equipment by issuance of serial bonds in the aggregate principal amount of \$94,400 pursuant to a bond resolution dated May 26, 2020 (the "\$94,400 BAN"); and

WHEREAS, the \$94,400 BAN will mature on June 11, 2021;

NOW, THEREFORE,

BE IT RESOLVED, by the Town Board of the Town of East Bloomfield located in the County of Ontario, New York, by the favorable vote of not less than two-thirds of all of the members of such Board, as follows:

Section 1. The Supervisor is hereby authorized to pay the sum of \$47,200 on the principal balance of the \$94,400 Renewal BAN, plus interest of \$1,882.76 to Canandaigua National Bank and Trust Company on June 11, 2021, and shall renew the Bond Anticipation Note with Canandaigua National Bank and Trust Company for a one-year term. The renewal serial bond amount shall be \$47,200 with an interest rate of 1.00% and shall mature on June 10, 2022.

Section 2. This Resolution shall take effect immediately upon its adoption.

WHEREAS, the Town Board (the "Board") of the Town of East Bloomfield (the "Town") having previously authorized the purchase of a 2020 International Model #HX620 SBA 6/4 Plow Truck (the "Equipment") for the Town's use and the financing thereof to partially defray the costs of the Equipment by issuance of serial bonds in the aggregate principal amount of \$236,000 pursuant to a bond resolution dated May 11, 2020 (the "\$236,000 BAN"); and

WHEREAS, the \$236,000 BAN will mature on June 11, 2021;

NOW, THEREFORE,

BE IT RESOLVED, by the Town Board of the Town of East Bloomfield located in the County of Ontario, New York, by the favorable vote of not less than two-thirds of all of the members of such Board, as follows:

Section 1. The Supervisor is hereby authorized to pay the sum of \$47,200 on the principal balance of the \$236,000 BAN, plus interest of \$4,706.89, to Canandaigua National Bank and Trust Company on June 11, 2021, and shall renew the Bond Anticipation Note with Canandaigua National Bank and Trust Company for a one-year term. The renewal serial bond amount shall be \$188,800 with an interest rate of 1.00% and shall mature on June 10, 2022.

Section 2. This Resolution shall take effect immediately upon its adoption.
